## **INSIDE INFORMATION EXPECTED IMPROVEMENT IN LOSS POSITION**

This announcement is made by Aurum Pacific (China) Group Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the assessment of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2019, the Group expects to record a decrease in loss attributable to owners of the Company for the nine months ended 30 September 2019 as compared with the loss attributable to owners of the Company of approximately HK\$15,279,000 for the nine months ended 30 September 2018.

It is expected to record a decrease in loss attributable to owners of the Company mainly due to (i) a decrease in administrative expenses and research and development expenses as compared to the same period last year; (ii) the absence of the one-off loss on disposal of associates recorded in last year; and (iii) the absence of recognition of estimated changes in fair value of consideration payable for business combination recorded in the same period last year as a result of the redemption of the promissory note in the fourth quarter in 2018.

The Company is still in the process of finalising the unaudited third quarterly results of the Group for the nine months ended 30 September 2019. The information contained in this announcement is only based on the Board's assessment on the latest information currently available and the unaudited consolidated management accounts of the Group. Shareholders and potential investors are advised to read carefully the unaudited third quarterly results announcement of the Group for the nine months ended 30 September 2019, which is scheduled to be published on 8 November 2019.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**
