EXPECTED SIGNIFICANT DECREASE IN LOSS

This announcement is made by Aurum Pacific (China) Group Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2018, the Group is expected to record a substantial decrease in the unaudited consolidated loss attributable to owners of the Company for the six months ended 30 June 2018 as compared with the unaudited consolidated loss attributable to owners of the Company for the six months ended 30 June 2017.

The expected decrease in the unaudited consolidated loss attributable to owners of the Company was mainly attributable to (i) a decrease of approximately HK\$2.34 million in the recognition of estimated changes in fair value of consideration payable for business combination relating to the acquisition of 60% equity interest in First Surplus Investments Ltd. and its subsidiaries (the “**acquisition of FS Group**”) as compared to the same period last year; (ii) a decrease of approximately HK\$3.38 million of the recognition of fair value changes of contingent consideration assets for business combination relating to the acquisition of FS Group as compared to the same period last year; and (iii) a decrease of approximately HK\$8.34 million in administrative expenses as compared to the same period last year.

The Company is still in the process of finalising the interim results of the Group for the six months ended 30 June 2018. The information contained in this announcement is only based on the Board's preliminary assessment of the unaudited consolidated management accounts of the Group and the information currently available which have not been audited by the auditor of the Company. Shareholders and potential investors of the Company are advised to read carefully the announcement on the unaudited interim results of the Group for the six months ended 30 June 2018, which is expected to be published on 10 August 2018.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
